- The school will enroll students proportionate to the facilities available in the school as
  prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the
  continue number as under from Pre-Primary to Class XII:

- 8. Other conditions are contained in Annexure 'A' which is enclosed herewith.
- Special conditions to be complied within 30 days:
  - a. The Extension of Provisional Affiliation up to Senior Secondary level w.e.f. 01/04/2016 to 31/03/2021, has been granted provisionally subject to the conditions that the school will Pay the pay scale and allowances which should at least be at par with corresponding categories of teachers employed in government institutions of the State Govt, or as per scale prescribed in 6th Central Pay Commission of Govt, of India in respect of its teachers and will make payment by the school through ECS mode.
  - b. The School Managing Committee has not been constituted as per norms; therefore it may be reconstituted by including two representatives of each parent, teachers and Board's nominee. Therefore, the school is required to forward 5-6 names of principals of the nearby CBSE affiliated school (2-3 of them may be from KVs/JNVs) for approval 02 of them as Board's nominees in school Managing committee.

c. The school is also required to furnish valid Sanitary Conditions, Drinking Water and Fire Safety Certificates issued by the competent authorities.
